#### Anglian Water Eco Advocates Award evidence

- We will notify the school if the school has successfully supplied the evidence to complete the Anglian Water Eco Advocates Award.
- If insufficient evidence is supplied the school will be notified by email ("Further Evidence Email").
- A discretionary period of not less than 10 working days from the date of the Further Evidence Email can be granted to enable the school to supply further evidence.
- In the event of no supplemental evidence being submitted to us within 10 working days from the date of the Further Evidence Email the school's application for the Anglian Water Eco Advocates Award will be at an end.

#### Prize

- Upon successful completion and submission of the evidence required to complete the school's application for the Anglian Water Eco Advocates Award:
- A water butt will be dispatched to the address specified in the MS Form submitted by the school
- The prize(s) is non-exchangeable and non-transferable.
- Anglian Water reserves the right to swap the water butt illustrated for a suitable alternative.
